You may choose only the items you desire. **However, any funeral arrangements you select will include a charge for our basic services and overhead.** If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected. Certain funeral services may be provided off premises by other funeral service providers.

1. PROFESSIONAL SERVICES OF FUNERAL DIRECTOR AND STAFF	\$3,125.00
<i>This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.) Our fee for the services of funeral director and staff includes, but is not limited to, staff to respond to initial request for service; arrangement conference with family or responsible party; arrangement of funeral; preparation and filing of necessary authorizations and permits; recording vital statistics; preparation and placement of obituary notices; staff assistance prior to and following the funeral, including coordination with those providing other portions of the funeral, e.g. cemetery, crematory, and others. Also included in this charge are overhead expenses relative to our facility, such as insurance, maintenance and utility expenses, secretarial and administrative costs, and equipment and inventory expenses.</i>

2. EMBALMING	
<i>Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial. Includes use of a Virginia registered embalming / preparation room in compliance with EPA, OSHA, Virginia Board of Funeral Directors and Embalmers and medical waste regulations. Also includes a Virginia licensed embalmer to perform the embalming procedure.</i>

<i>“State and local laws do not require a casket for direct cremation. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering.) The containers we provide are cardboard and fiberboard. Our charges, without any attendant rites or ceremonies, includes professional services of funeral director and staff, crematory fee, service car, transfer of remains to funeral home, and medical examiner fee. (Does not include refrigeration fees.)</i>
