Also included in this charge are overhead expenses relative to our facility, such as insurance, maintenance and utility expenses, secretarial and administrative costs, and equipment and inventory expenses.

2. EMBALMING

Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial. Includes use of a Virginia registered embalming / preparation room in compliance with EPA, OSHA, Virginia Board of Funeral Directors and Embalmers and medical waste regulations. Also includes a Virginia licensed embalmer to perform the embalming procedure.
